

Interactive nuggets common structure





This Newsletter is dedicated to the Second Transnational Meeting of the partners, held on 06-07 February 2023 in Sofia, Bulgaria. This workshop was of particular importance for the quality implementation of the project, as the most essential tasks of the Action Plan were discussed. Most of the time was devoted to the strategy for developing the short educational video fragments (learning nuggets) intended for implementation in the educational content of various scientific disciplines. The following main tasks were outlined:

- Identification of existing practices on using learning nuggets in higher education (R2/A1)
- Development of Sharing platform (R2/A2) Based on deep discussion the consortium partners selected Moodle based platform which to be configured according to Cyber IN Practice specific purposes
- Development of interactive materials (R2/A3 and R2/A4) A thorough analysis was made according to the Pilot training foreseen. Through it, it will be checked how the developed interactive learning materials are embedded in the learning content of different scientific disciplines and to what extent the nuggets contribute to the acquisition of knowledge about cyber attacks and cyber security. The thematic areas of cyber security to which the specific interactive materials (learning nuggets) will be dedicated were also selected. The implementation of the specific Cyber Security topics was distributed among the partners.

Since the subsequent pilot testing of the created learning interactive materials is closely related to the implementation of the listed tasks, during this meeting, time was also devoted to the preparation for the implementation of the pilot tests in partner countries.

A clear distribution of tasks was made and precise deadlines were set. This guarantees their effective implementation and achievement of the desired results.
